**Call for Submissions to the Yukon Permanent Art Collection**

## **SUBMISSION GUIDELINES**

The Yukon Permanent Art Collection provides Yukoners and visitors with an opportunity to experience our cultural legacy as it is expressed through the visual arts, and contributes to the professional development and economic well-being of Yukon artists.

We are looking for work that demonstrates exceptional skill, innovation, originality and vision.

The Friends of Yukon Permanent Art Collection can spend up to \$60,000 on new artwork for the collection annually.

Artists of all backgrounds, at any stage of their creative paths and from all communities are invited to apply.

This includes and is not limited to Indigenous, Black, and racialized people; refugees, newcomers and immigrants; LGBTQ+, Two-Spirit and non-binary people; people with disabilities; and those with low-incomes or living in poverty.

If there are any barriers or challenges to applying, contact us so we can find a solution.

**Deadline for submissions: January 31 at 4:30 pm**

**Note:** Applications must be received by 4:30 p.m. on the deadline date. If a deadline falls on a statutory holiday or weekend, the deadline will be extended until 4:30 p.m. on the next working day.

Keep in mind the following when considering work to submit:

- Work will be juried in March
- Results will be sent by mail and e-mail promptly.

### **Submission requirements**

- Up to three (3) works per artist.
- Artwork in the Yukon Permanent Art Collection is most often displayed in public spaces such as lobbies and waiting rooms, rather than in galleries. These spaces generally accommodate 3D work up to 36"x36"x24" and 2D work up to 48"x60". Artists considering submitting work exceeding these dimensions should consult with the art curator.
- Some display spaces with higher light levels are more suited to artwork made from durable and light-tolerant materials such as metal, glass, ceramics, carvings with high quality lightfast paints, and some recycled materials. Selections will not be limited to works made from these materials, however to take full advantage of available display spaces, submissions of this kind of artwork are encouraged.
- Artwork should be complete; artists interested in submitting work in progress should consult with the art curator.
- Artwork in a wide variety of media is eligible. At this time, artwork with technical display requirements such as video and sound-based work, cannot be accepted while resources to care for and exhibit this kind of work are being reviewed.

- If a submitted artwork is part of an edition of prints or photographs, this information should be included in the submission.
- Shipping costs (if necessary) are the responsibility of the artist.
- Prices should include 5% GST, if applicable.
- If work submitted is already sold, alternate work will not be accepted.
- Do not send the physical artwork; send images (see following page).

## Ownership and content

- Artwork must be original work created by the artist.
- The Friends of Yukon Permanent Art Collection and the Government of Yukon strive to respect and support the culture and traditions of Yukon First Nations and all Indigenous peoples. In line with the values and principles described in the Canada Council for the Arts' *Supporting Indigenous art in the spirit of cultural self-determination and opposing appropriation* statement, we commit to "respect the histories, traditions, languages and contemporary practices of Indigenous peoples".

## Artist eligibility

- Work will be considered from all artists; however, preference will be as follows:
  1. Yukon artists – an artist with 12 months residence on the closing date of the call for submissions. A resident is an individual who has, as their primary place of living, a Yukon address.
  2. New or temporary Yukon artists – an artist living in the Yukon with less than 12 months residence on the closing date of the call for submissions.
  3. Expatriate artists – an artist who was previously a Yukon resident but no longer has a Yukon address.
  4. Non-Yukon artists – an artist who does not and never has lived in the Yukon whose work has a resonance in the north.
- Work will not be acquired from artists whose work has been purchased for the collection within the last two (2) years.

## Images

- Prints or digital images are acceptable; submit only one format. Multiple images of each work will be accepted; details are encouraged.
- Images submitted should be of the highest possible quality. Applicants requiring assistance can contact the art curator (see contact information below).
- **Printed images:**
  - Prints should be clearly labeled with artist's name and title of work. If submitting details, number prints in order of viewing, e.g. 01, 02, 03 etc.
  - Submit with completed Yukon Permanent Art Collection submission application.
- **Digital images:**
  - Digital images should be either jpg or tif files at a resolution of 150 dpi or higher with a suggested dimension of 1800 pixels on the long edge. Maximum suggested file size is 2.5MB.
  - Images must be PC compatible.
  - Label each file (image) with the artist's name and the title or the work in the following format: last\_name\_first\_name\_title of work (e.g. doe\_jane\_untitled.jpg).
  - If detail images are included, label each file (image) with the artist's last name, first name, title and sequential number (e.g. doe\_jane\_untitled01.jpg, doe\_jane\_untitled02.jpg).
  - Submit on a single USB with completed Yukon Permanent Art Collection submission application. Images in jpg format may also be emailed.

## Support

- Hard copy forms are available from the Arts Section, Department of Tourism and Culture, 100 Hanson Street, and from the Yukon Arts Centre.
- Free photography and information sessions will be offered to assist artists with their submissions. Contact the art curator for more information.
